







How does AASHTO Helps States?

- Develop and maintain technical standards and specifications
- Produce best practices guides and manuals
- Provides a forum for consideration on transportation issues
- Provide professional development
- Conduct surveys, provide data, and testify on legislative issues
- Technical Service Programs







How else does AASHTO work with?

The AASHTO collaborates with a variety of NGOs and associations to advance transportation initiatives.

- American Public Transportation Association (APTA): AASHTO collaborates with APTA to promote public transportation systems across the United States.
- Institute of Transportation Engineers (ITE): AASHTO works with ITE on developing standards and best practices for transportation engineering.
- **Transportation Research Board (TRB):** AASHTO partners with TRB to support research and innovation in transportation.
- American Society of Civil Engineers (ASCE): AASHTO works with ASCE on infrastructure projects and engineering standards.

These partnerships help AASHTO to foster a comprehensive and integrated transportation system across the nation.

Policy and Government Relations

Work with Congress, Executive Agencies, and industry stakeholders to represent the policy interests of all state DOTs:

- Develop legislation such as the IIJA and IRA
- Providing state DOT perspectives on implementation of federal transportation programs
- Provide input on federal rulemaking and regulations
- Build partnerships with peer associations, private sector, federal, state, and local governments, academia, etc.





Surface Reauthorization

- October 2024: TPF to review committee white papers; 2024 AASHTO Annual Meeting, Philadelphia, PA
- October 2024 to March 2025: Modal Councils and Special Committee on Freight to develop and approve their policy recommendations white paper
- March 2025: TPF to review Modal and Special Committee white papers; 2025 AASHTO Washington Briefing; Washington, DC
- March 2025 to May 2025: TPF to develop and review draft policy resolutions
- May 2025: TPF to deliberate on draft policy resolutions developed to date; 2025 AASHTO Spring Meeting
- August 2025: TPF to hold a special session to finalize and adopt draft policy resolutions for Board consideration, amend white papers as necessary, and develop legislative outreach strategy; Location TBD
- October 2025: AASHTO Board of Directors to consider and formally adopt policy resolutions, and amend white papers as necessary; 2025 AASHTO Annual Meeting
- October 2025 to September 2026: AASHTO members and staff to communicate and explain AASHTO's formal policy positions
- September 2026: IIJA expires on September 30, 2026


